- We will target local and national organizations to let them know about the conference

- Soon many leaflets will be printed, everyone will carry leaflets with them and bring them to conferences, demos, etc.

#### **Prisoner Involvement:**

- Kim Pate suggested that we set up video conferencing for prisoners who can't attend the conference, Gord and Tom will arrange setting up the video conferencing
- Kim, Tom, Rick, Vivian, and Lisa will meet with Ole in Ottawa to discuss video conferencing for long-distance prisoner participation and ETAs for travelling-distance prisoners.
- Kingston folks will try to arrange citizens escorts
- Rick is working on getting video clips of prisons
- We will work on setting up a bulletin board at the conference with postings of letters from prisoners
