Proposal for ICOPA Steering Committee and Website

ICOPA has been in existence since 1983 and has held conferences every other year since, in many parts of the world including Africa, Australia, Europe and the Americas.

It has a long tradition of informal collaboration and no central committee and remains fairly low-key in between conferences. But prison issues do not. Some in ICOPA are considering increasing its profile to reach more people and disseminate more information on the proliferation of prisons and injustice, and provide a dynamic space where folks can exchange ideas on abolition, announce events and post information.

This could be done by creating a permanent website for ICOPA, which could also serve as the place to advertise the upcoming ICOPA conference, the call for papers, registration information, etc. In addition, a website could serve as an archive for ICOPA materials (writings, videos, past ICOPA footage), and offer a means to facilitate continuity between conferences.

A new permanent ICOPA website will necessitate hands-on people and it is proposed that a steering committee be created that would be charged with undertaking the building of a website in order to promote our abolitionist objectives.

It is suggested that ICOPA strike such a committee composed of few people, who would be mandated for a two-year period, to oversee and maintain a new ICOPA website.

We ask that you reflect on this, with a view to discussing it at the end of this conference.

Among other things, it would be of interest to know what YOU think such a committee should be tasked with; what you think of the idea of creating a permanent website; what you would like to see on such a website; and whether you have other ideas to bring forth that would enhance ICOPA's profile in the world.

Your suggestions are most welcome. It is hoped that you will take advantage of this time together to discuss this matter, during breaks, over a pint, or a cup of tea, with fellow delegates.
